3. Supervisory activities of the Board of Directors over the Executive Board:

Supervision method:

- Supervise and approve reports at the Board of Directors meeting (in the period of the first 6 months of 2025, 18 meetings were held). The evaluation of the implementation of the 2025 plans and objectives approved by the General Meeting of Shareholders, along with the Board's directives, was conducted via email.
- The Governance, Human Resources and Legal Subcommittee; and the Investment Subcommittee: Supervise financial aspects, risk management, and compliance control in investment and business plans.
- The meetings were expanded with the participation of the Head of the Supervisory Board, Executive Board and issued decisions to orient the Executive Board to implement, issued 23 resolutions and decisions related to key issues of the Board of Directors.
